Portland Plays Host to 92nd Convention



Convention attendees tour downtown Portland

A week of perfect weather, and Mount Hood clearly visible on the eastern horizon, welcomed delegates to the 92nd annual Union Pacific Employee Clubs Convention.

Gathered at the Sheraton Portland Airport Hotel, delegates and their guests — more than 130 people — celebrated the clubs' accomplishments and charitable efforts in the past year, which included 65,671 hours of community service, 163,513 miles driven and total donations in excess of \$1.1 million.

Individual club awards were presented during an Aug. 3 luncheon by UPEC Executive Committee Vice Chairman Mike Roe and Patricia LaBounty, UP Railroad Museum and collections manager, who also gave a presentation about how past U.S. presidents have used rail transportation during their tenures. The remainder of the honors were presented during a banquet the following evening, at which Vice President-Public Affairs Wes Lujan discussed the current state of UP business and the company's relationships with communities along the West Coast. UPEC members play a key role in building those relationships, he said, and he thanked attendees for their efforts in furthering them.

During the day, delegates discussed important club matters and held elections for the coming year's executive committee. Each night, attendees gathered to enjoy fine food and conversation. The annual pin night and auction, held Aug. 2, raised nearly \$6,000, split three ways between UPEC Friend to Friend Network, the Oregon Humane Society and UPEC Make-A-Wish Foundation. Everyone returned to the ball-CONVENTION room the following night - this time undercover as various superheroes and heroines - for Theme Night.

Throughout the convention, attendees enjoyed tours of the city and wineries of Oregon's Willamette Valley, and visited the majestic Multnomah Falls and Columbia River Gorge.

Kevin Hanlon reassumed the UPEC Executive Committee chairmanship Aug. 4 during the convention. Succeeding Dale Fulenwider, he previously served as 2006-2007 chairman.

The Lohrville, Iowa, native joined UP in April 1999 in nearby Boone and completed training in Chicago and Des Moines. Borrow-outs later that year took Hanlon to Bill, Wyoming, and St. James, Minnesota, where he has since remained in various conductor roles. He later served as a yardmaster and peer trainer.

Early in his St. James tenure, he often worked with Locomotive Engineer John Erickson, the first UPEC 70 president and husband of current president Cleo Erickson. Hanlon eventually succeeded him as club president.

He has been an active Executive Committee member more than a decade.

In his second term as chairman, Hanlon's biggest goal will be to increase the clubs' ranks, which means bringing back inactive clubs. He also would like to bring the "adopt-a-club" practice back to the convention.

"Be ready for Sacramento next year," he said. "We had a great convention the last time we were there. Presidents, get the word out."

Hanlon and his wife, Cindy, have five grown children. When not railroading or tending to UPEC matters, they enjoy motorcycling and gardening.

Friend to Friend Assists Flood Victims

UPEC Friend to Friend Network exists to help employees and their loved ones in times of need - and at least 80 have been affected by significant August flooding in Louisiana.

Parts of the state, particularly near Baton Rouge, received nearly 30 inches of rain. Floodwaters damaged about 40,000 homes and more than 70,000 residents registered for FEMA assistance.

One hundred percent of collected donations go directly – and only – to UP families.

"Friend to Friend is a great opportunity to ensure your donations directly help your fellow employees," said Chad Wilbourn, regional vice president-Southern Region. "UP is a big family always looking to help one another." Additionally, Union Pacific donated \$10,000 to the American Red Cross Aug. 19 to assist with relief efforts. Created in 2004, UPEC Friend to Friend Network has since helped more than 9,000 Union Pacific employees, retirees and their families, and distributed more than \$5 million. Online applications can be submitted for any Union Pacific employee, retiree or family member (spouse or child) who has suffered a medical-related emergency that required hospitalization or time off work, or a dwellingrelated emergency following a fire, flood or other weather event that caused them to be out of their primary home.

In 2015, monthly payroll deductions topped \$57,000 with more than 7,000 employees donating per month. The entirety of each donation goes to helping someone in need. On average, Friend to Friend Network helps five railroad families every day.

Employees can access the Friend to Friend site

either at work or from a home computer. It allows employees to manage their monthly contributions online and provides instructions for becoming an ambassador. Visit Friend to Friend Network on UPOnline for more information.
